Cash price for a diver is \$1715 (\$1775 for credit card purchase) with double occupancy of the room (call for single prices, as well as non-diver prices, and other room choices, i.e., Seaside or Beach Front). Dinner add-or is available for \$255 (plus \$55 tip) for any five dinners at the resort.
	_ Airfare is not included in the trip price. Travelers need to make their own reservations either online, through a travel agent, or by using frequent flier/air miles. Travelocity and Yahoo Travel currently have round trip flights for about \$700.
	A minimum of \$500 per person Non-refundable deposit is required to guarantee your reservation. Payment in full is due by April 1, 2024.
	Cancellations received ninety (90) days or less prior to departure will only be refunded if a replacement for that space can be found.
