

## WAIVER AND RELEASE OF LIABILITY FOR TRAVEL to BARBADOS, JUNE 16-23, 2018

Please read the following conditions and circumstances for ProTech Scuba, LLC's Exotic trip to Barbados.

**You must initial each space and sign and date at the bottom. It is your responsibility to read and understand the information provided.** A copy of the document will be provided upon request.

\_\_\_\_\_ Package includes: 7 nights at Coconut Court Beach Hotel in (Bridgetown) Barbados with ocean view studios (fully refurbished with two twin beds or one king bed), all taxes, **all meals**, airport transfers, 5 days 2 tank dives (plus 2 extra dives), tanks, weights, weight belts, free WIFI, and iPod docking station. \$1720 per person, double occupancy, Ocean View Room (\$1660 pp dbl occ for cash/check)  
\$1220 per non-diver, double occupancy, Ocean View Room (\$1160 pp dbl occ for cash/check)  
\$TBD per person, single occupancy, Ocean View Room (\$TBD single occupancy for cash/check)

\_\_\_\_\_ Airfare is not included in the trip price. Travelers need to make their own reservations either online, through a travel agent, or by using frequent flier/air miles. Travelocity and Yahoo Travel currently have round trip flights for about \$800.00.

\_\_\_\_\_ A minimum of \$500.00 per person **Non-refundable** deposit is required to guarantee your reservation. Payment in full is due by April 9, 2018.

\_\_\_\_\_ Cancellations received ninety (90) days or less prior to departure will only be refunded if a replacement for that space can be found. It is not ProTech Scuba, LLC's responsibility to find your replacement, but we will do our best to help find that replacement. **Trip insurance is strongly recommended.**

\_\_\_\_\_ As with all of ProTech Scuba, LLC's trips, you are free to make your own plans or you can follow our schedule while in Barbados. Eric will let you know what our schedule is and will help to make arrangements for other excursions during the trip. Feel free to make suggestions and/or ask questions about extra activities.

\_\_\_\_\_ The local currency is Barbados dollars (1.98:1) and the electricity is 110v just like in the US. Even though all of the basics are included, you may want to have a credit card for extra excursions and \$100-\$200 cash for incidentals. Tips are not included and may run \$120 to \$200 per person for the week.

\_\_\_\_\_ US Citizens must have a current valid passport for all travel outside the country. This passport must be valid for at least 6 months after your trip dates (until December 14, 2018)

\_\_\_\_\_ Fuel surcharges are subject to change up to the time tickets are issued. Due to this, fuel surcharges are not included in the published trip price. Fuel surcharges will be an additional cost due when you receive your tickets (if applicable).

\_\_\_\_\_ With regards to Airlines: The passage contract in use by the carrier, which upon issuance shall constitute a contract between said carrier and passenger, sets out the carrier's sole responsibilities. Schedules and prices are subject to change without notice. I further acknowledge and understand that evacuation by sea is a time-consuming process, and it may be complicated or delayed further by adverse weather conditions, equipment problems and other unforeseen circumstances.

\_\_\_\_\_ ProTech Scuba, LLC **strongly recommend that all divers have DIVE INSURANCE** in addition to trip insurance, for their own safety (e.g. DAN diving insurance).

\_\_\_\_\_ I hereby affirm that I have been advised of the inherent hazards and risks of participating in the Expedition, including, but not limited to: drowning, freezing, sickness, hypothermia, fire, injuries caused by heavy equipment, lacerations, crushing and other types of traumas and/or injuries.

\_\_\_\_\_ I hereby acknowledge that I do not have any injuries or sickness that could prevent my participation in the Expedition, or could require emergency medical treatment while I am on the Expedition, or could jeopardize the successful completion of the Expedition due to an emergency that could arise during the Expedition.
